- I. Call to Order: The meeting was called to order at 1:04pm.
- II. Welcome and Introductions: Attendees were welcomed, and introductions made.
- III. Approval of the Agenda for December 9, 2021: A. Tomczyk motioned for approval of the December 9 agenda. Z. Kotval seconded the motion. Motion passed.
- IV. Approval of the Minutes from November 10, 2021: E. Heideman motioned for approval of the November 10 minutes. K. Neve seconded the motion. Motion passed.
- V. Public Comment and Correspondence:
  - **T. Lemmer** welcomed Nicole from Rich's Residential and Home Care Options as a guest.



- **T. Lemmer** also shared that changes in telephone technology are coming. Devices that use 3G network are going to be obsolete. More information will be shared as we get it. Currently, the best solution is to contact your own carrier and confirm whether or not you need to change devices and confirm what their timeline is. Discussion followed. **A. Tomczyk** mentioned area codes in the St Johns area are now required even when dialing from within the area.
- VI. Executive Director's Report: M. Owen shared that booster shots are becoming more important. Break through cases are increasing. TCOA received money from the State intended to increase vaccine access. Currently, TCOA is thinking about creating and sending postcards, and may even buy lists of contacts. The message will serve as a booster reminder with information on how to contact TCOA for help with transportation or setting up an appointment. The goal is to reach those who may be confused or hesitant, not just for the booster but vaccines in general. Discussion followed.

TCOA is still in discussions about the AARP sponsored Tax Assistance Program which is traditionally hosted at the TCOA office. Options are being discussed such as drop offs and/or virtual appointments.

TCOA is still waiting for American Rescue Plan Act (ARPA) relief money from the State. The funds are available through Fiscal Year 2025.

Millage money has been crucial for service delivery, especially for Meals on Wheels and home repair for keeping people safely in their homes.

Marion then wished the council a safe and happy holiday season with appreciation for everyone's time and support.

#### VII. Old Business

## A. Agency Term Recommendations

**T. Lemmer** noted that there will be two agency seats vacant as of January due to term limits. M. Pineda entertained a motioned to approve Hospice of Lansing as an agency seat on the council. **A. Turner** made the motion. **C. Mask** seconded the motion. Motion passed. (Editor's note: there should have been three vacancies announced -CATA, MSU School of Nursing, and McLaren).

Discussed later in the meeting, Z. Kotval-Karamchandani will fill the second agency vacancy as the MSU School of Planning, Design and Construction.

## X. Council Reports

## A. Social Security Administration:

**R. Ford** shared that there is no solid date for reopening the lobbies. Critical needs that warrant an in-person appointment do happen, but it is rare. The new Medicare premium has been announced at \$170.10. R. Ford then reviewed some handouts that were shared with the council (MY SOCIAL SECURITY'S FOUR SUPER POWERS and Medicare 2021 and 2022 costs at a glance.) The Administration continues to promote online services, especially because a significant number of offices in lower Michigan are seeing a major increase in calls and appointment requests due to retirement numbers going up. Retirement estimates can be found online. R. Ford provided an overview of services on the web.

## **B.** Michigan Senior Advocates Council:

**T. Lemmer** shared that the big topic of discussion is the ARPA money as mentioned by Marion. A letter will be sent on behalf of the Council as an appeal discussing the unmet needs that could be addressed with the funds. There has been some discussion on Auto No-Fault and continuing concerns. T. Lemmer and M. Owen noted that 4AM contracts with a lobbyist firm and they are interviewing four new firms to hopefully broaden the reach and influence.





## **B.** State Advisory Council:

**R. Ford** was unable to attend the last meeting. Therefore, no report was provided.

#### **D.** Nutrition Council:

**C. Buonodono** announced that Meals on Wheels has transitioned home delivered meals back to once-a-week deliveries for most clients out of an abundance of caution. A few congregate dining sites are open, but there are no plans for more to open at this time.

### F. Transportation Advisory Boards

**CATA/D. Wiese:** Contact Craig Frazier, CATA Paratransit manager (517-394-1100) if a TCOA Advisory Council member within the CATA service area is interested in learning more about or applying for the Local Advisory Committee. D. Wiese then shared CATA data as it relates to ridership related to COVID.

COVID Testing: 96 rides, 108 tests

COVID Vaccinations: 1704 rides, 1989 vaccinations (Paratransit), 700+

rides/vaccinations (Fixed Route)

CATA has reissued the mask requirement for all CATA buildings/facilities.

Paratransit is now averaging over 800 calls per day ("normal" is 850 - 1,000) averaging 1100 rides per day ("normal" is 1500+).

October 2021 was the largest Paratransit ridership since March 2020.

**Eatran/J. Gutierrez:** Councilmember had to leave the meeting prior to reporting. Therefore, there is no update.

Clinton Transit/A. Tomczyk: Nothing to report, but there may be information to share next month about a possible new project.
